

Agreement on the Commercial Use of WUNDERKIDDY Materials

This Agreement establishes the terms for granting and using a commercial license for copyrighted works, including educational and teaching materials and worksheets, posted on the website www.wunderkiddy.com.

Payment for the commercial license constitutes the User's (hereinafter referred to as the Licensee) full and unconditional agreement to all provisions of this document.

1. Scope of the License and Benefits for the Licensee

Purchasing a commercial license from Wunderkiddy grants the Licensee the right to legally use the platform's copyrighted materials for their own educational, publishing, and commercial activities.

The Licensee may modify the design, edit the content, and remove Wunderkiddy's logos and QR codes.

2. Licensee's Rights (Permitted Uses)

A holder of a valid commercial license has the right to:

- Use the materials in the operation of kindergartens, schools, development centers, and other private or public educational institutions.
- Produce, print, and sell an unlimited number of physical copies of Wunderkiddy materials as part of their own products. No additional fees, charges, or royalties are required based on the number of copies sold.
- Print the materials and distribute them free of charge to your clients, students, and their parents.
- Use the materials to create your own commercial print products, such as worksheets, books, magazines, brochures, and workbooks intended for resale.
- Sell physical (printed) copies of the materials as a separate product.
- Edit, adapt, translate, and modify the materials to suit your needs.

3. Restrictions and Prohibitions

To protect Wunderkiddy's intellectual property, the Licensee is strictly prohibited from:

- Distributing original or modified digital files (PDF, PNG, etc.) on the Internet for third parties to download for free.
- Selling Wunderkiddy materials in digital form (for example, selling PDF files) on marketplaces or other websites unless a new, complete product is created (e.g., a book or course).
- Transferring rights under this license, reselling the license, delegating it, or assigning it to third parties.
- Prohibition on Misrepresentation and Brand Use: The Licensee is strictly prohibited from representing themselves as the author of the original materials, an official representative, a partner, or a subsidiary of the Wunderkiddy platform. Although the Licensee may remove logos from worksheets, they may not use the Wunderkiddy name, logo, or branding elements to advertise their own courses, books, or other commercial products without the written consent of the copyright holder.
- Prohibition on Registration of Rights: The Licensee may not register trademarks, patents, or copyrights for Wunderkiddy materials in their own name, even if the materials are modified or adapted. The Licensee may not use the name "Wunderkiddy" in the names of their companies, brands, or domain names.
- Reputational Restrictions: Using Wunderkiddy materials in projects that contain promote violence, discrimination, profanity; or that violate applicable laws or could damage the platform's business reputation is prohibited.

4. Financial Terms and License Validity Period

The cost of a commercial license is 250 USD per year.

Payment is automatically deducted annually on the license purchase date (auto-renewal).

If the annual payment cannot be processed (due to insufficient funds, an expired card, or a similar issue, the license will be automatically suspended, and the right to commercial use of the materials will be revoked until full payment is received.

5. Termination of the Agreement and Liability of the Parties

The Licensee may terminate this Agreement via their personal account on the website or in the mobile app (in the “Subscriptions” section). In this case, the Agreement will end on the last day of the current paid period, and no refunds will be issued for the unused period.

The Wunderkiddy platform reserves the right to revoke the commercial license at any time. In this case, the Licensee will be refunded the amount paid for the last (current) year of the license's validity.

In case of license revocation, the Licensee agrees to immediately cease sales and remove all Wunderkiddy materials from all public and private sources, including websites, courses, and points of sale, within three months.

The maximum financial liability of the Wunderkiddy platform to the Licensee for any claims is strictly limited to the cost of the annual license. All copyrights to the original materials belong in full to the Wunderkiddy platform.

6. Scope of the License

This license is valid on a global scale, with no territorial limitations, and allows the Licensee to sell its end products worldwide.

7. No Third-Party Claims

The Licensee bears sole and complete responsibility for the quality and content of the end products it creates (books, magazines, courses) and for its customers, students, and third parties. Wunderkiddy does not engage in disputes between the Licensee and its customers.
